I wanted to take a minute to introduce myself and let you know the purpose of this letter. I am Elizabeth Bennett and I help those who are abused by their peers. I am also a fellow believer and my life is dedicated to Jesus Christ. I also help our sweet friend I am about to introduce you to.

My purpose in sending this is that we have a sister who is in trouble and has been for quite some time. Are you familiar with the Pamela Smart case? It was the first case to go live on Court T.V. back in 1991. I invite you to visit her website at <http://www.pamelasmart.com> as her full story can be found there.

I have been in touch with Ms. Smart for quite a while and believe in her innocence. Also, there is a team uncovering a lot of information that was not brought to trial or even considered. Ms. Smart was sentenced to a life without the possibility of parole. She is paying with her life for the crimes of others. This is a woman who loves Jesus and does not hurt others. This June, Bill Flynn, the man who pulled the trigger, murdering Gregory Smart, and Patrick Randall, the man who held Gregg Smart down, while Flynn murdered him, have been paroled after having a 40 year sentence reduced to 25 years. The same with his accomplice.

*Love the Lord your God with all your heart and with all your soul and with all your strength and with all your mind'; and, 'Love your neighbor as yourself.'"* Luke 10:27 NIV edition. This is a verse Ms. Smart lives by.

Ms. Smart has served for many years within the prison and helped inmates with schooling, thwarting suicide and has facilitated many groups. She is also serving the Lord gratefully. However, she deserves her freedom. Her parents are getting older and her mother's greatest desire is be able to see her daughter free. Here are some specifics of things she has done on behalf of the Lord:

- She completed a Discipleship Training Program, Presider Training and a Clinical Pastoral Unit.
- She was chosen by the Pastor to be a leadership member and has done so for over a decade.
- She is in Prison Fellowship Bible Study on Monday evenings.
- She is the Director of the Liturgical Dance Ministry.
- She presides over church services on a regular basis.
- She ministers to women who have HIV/AIDS.

It is a process but we are changing minds bit by bit. A documentary called, Captivated: The Trials of Pamela Smart, aired at the *Sundance Film Festival* back in 2014. It aired in several major cities and is available on H.B.O., H.B.O. Now, and H.B.O. Go currently. I invite you to check it out when you have an opportunity. The tide is turning and the Lord is working in her life. I see it daily.
